May Field Trip - South Brevard WTF, Viera FL

and LEAVE by 7:30AM SHARP. Bring binoculars, spotting scopes, field guides, sunscreen, insect repellent, water and a picnic lunch. We will bird until approximately 11:30-12:00 then enjoy our lunch at one of the observation towers.

President's Message LORETTA SATTERTHWAITE, PRESIDENT

Ivory-Billed Woodpecker in Arkansas!! Life-listers must be filling the airplanes to get to Arkansas after this latest report. On April 28, 2005, National Public Radio (www.npr.org) did a story about scientists who have been secretly studying this possible sighting for over a year. Only fleeting glimpses have been made, but some of them were caught on film, so it is believed that the Ivory-Bills are really not extinct. What an exciting find! Perhaps even more rare than this sighting is the fact that scientists and conservationists were able to keep this quiet to give conservation groups and government agencies time to protect the bird's habitat. The Nature Conservancy, along with the state and the federal Fish and Wildlife Service, had already been buying and protecting land along the White and Cache Rivers. Since the discovery, they've bought more land to protect the bird and its habitat. Kudos to TNC and the agencies involved in these purchases; typically when something of value is found in an area, the news leaks out and land prices skyrocket simply because

of the urgency of acquisition (i.e. greed at taxpayers expense).

About a month ago, I had an email from a former inhabitant of central Florida asking for information about Kraft Azalea Park in Maitland that had a plaque at the base of a tree that he believed commemorated an Ivory-Billed Woodpecker that lived in that tree. The writer questioned whether there might still be Ivory-Bills there. I did not find any information about the plaque (perhaps some of our long-time residents of Maitland can help with info?), and I responded to the gentleman and told him that the Ivory-Billed was indeed extinct — that searches in Louisiana in the previous year or two, in response to other 'sightings', had been unable to verify its existence. Perhaps I, and others, have been too quick to think the worst. Once again, the wonders of Nature are overwhelming.

How to continue after that introduction? Let me simply state that it is for that very reason that one of the missions of the OAS Chertok Nature Photography Contest (see related article) is to promote interest and

concern for preserving the native fauna and flora of Florida. If we all learn more about native Florida, perhaps we'll come to love it more and fight to protect it. The implication would be that we are protecting habitat that is the home of all kinds of creatures — no more "what good is it?"; its worth is that it exists — for whatever may come next. With that in mind, get your cameras in hand and venture out and take that photo that might spark an interest in helping to preserve natural Florida for the ages. The deadline is nearly upon us, so don't hesitate.

Again, I'd like to take this opportunity to thank all of you who have responded to OAS' fundraising appeals — the annual letter, the birdathon, volunteering to help at our fundraising/outreach events, etc. It has, so far, been a successful year for us and we are on target to make our budget. We couldn't do it without your continuing support. Remember it's not too late to sign up for our butterfly field course, another fun fundraising technique. The first of the three classes is May 7th; hope to see you there.

Conservation News PEGGY COX, CONSERVATION CHAIR

Good sense prevailed at the Orange County Board of County Commissioners early in April when the developers of the ICP Development of Regional Impact agreed to postpone the Comp Plan amendment hearing that had been scheduled for April 19th until this fall. District 4 Commissioner Stewart had asked for this action to allow the completion of the Environmental Resource Management Study that is underway in that south-

east part of Orange County. The Study will help the county address environmental impacts to nearby conservation lands and identify and address public infrastructure inadequacies before the ICP DRI is approved. OAS members will continue to be involved in helping identify concerns that need to be addressed by the Study. Gov. Bush and the Department of Community Affairs, with the backing of some Legislators, had proposed Growth Management Legislation that would have required concurrency in transportation and school capacity as a pre-requisite for development. This legislation wasn't to stop growth or even slow it down - but to require that public infrastructure would be in place to handle the impacts of this growth. It wasn't perfect - but it was a bolder attempt than we have seen in some time to make the investment in public infrastructure that is necessary to accommodate all the new development.

Unfortunately, as I write this, both the Senate and House bills dealing in these concurrency issues and other growth management problems have been weakened and amended to basically do little to change the current developer/builder driven process. Most of the State funds proposed for helping implement this legislation are for building more roads - under transportation concurrency - no plans for public transit and other modes of transportation that could effectively deal with Florida's growing population. The Legislative session ends on May 6th so by the time you read this - whatever is being sent to the Governor may or may not have the support of the environmental community. Fourteen OAS members and their guests enjoyed very nice walk in the park on Saturday, April 23, 2005 at Mead Gardens in Winter Park. The weather was great and the birding was just as good. We had thirteen (13) species of warblers; Orange-crowned, Northern Parula, Cape May, Black-throated Blue, Yellow-rumped, Prairie, Palm, Blackpoll, Black-and-white, American Redstart, Worn-eating, Northern Waterthrush and Common Yellowthroat. This is why we go to Mead Gardens and we certainly got our "money's worth". Altogether, we had 41 species for the morning. All in all, it was a good day for a walk in the park with good birding friends.

Ft. DeSoto Park Field Trip Report

On Saturday, April 9, 2005, thirty-three OAS members and their guests enjoyed an absolutely glorious day at one of the premier birding hot spots in North America, Ft. DeSoto Park in Pinellas County. After spending the night at nearby Eckerd College, we arrived at the park at 8:00 AM and split into two groups to better cover the park.

Although we did not see as many warblers as we would like to have, we had a really productive day, recording 73 species for the day. We had thirteen (13) species of Shorebirds between East Beach and North Beach. Some of the notable birds for the day were Red-throated Loon, Magnificent Frigatebird, Reddish Egret, Redhead and Lesser Scaup, Black-bellied and Semipalmated Plover, Whimbrel, Long-billed Curlew, Marbled Godwit, Pectoral Sandpiper, Short-billed Dowitcher, Bonaparte's Gull, Least Tern, Black-hooded Parakeet, Ruby-throated Hummingbird, Eastern Kingbird, Northern Rough-winged Swallow, Cedar Waxwing, Blackpoll and Black-and-white Warbler, Summer and Scarlet Tanager, Blue Grosbeak, Indigo Bunting and Orchard Oriole.

Many birders were able to list some "life" birds, which is always a treat. All in all, it was a good day to spend in a beautiful place with good birding friends.
